Sentrigard SYN-P Underlayment WARRANTY

10-Year Limited Warranty*

Using Sentrigard SYN-P Underlayment originally installed entitles you to certain quality assurance standards as provided in this System, Materials and Labor 10-Year Limited Warranty ("Warranty").

What is Covered

Sentrigard SYN-P originally installed after November 1, 2011 will conform to the air and water penetration resistance properties in the applicable Physical Properties Data Sheet in effect at the time of manufacture, using Gurley Hill (TAPPI T-460), for a period of ten (10) years after the date of installation of the Sentrigard SYN-P, when the problem is caused solely by the failure of the Sentrigard SYN-P to meet those properties in the applicable Physical Properties Data Sheet.

This Warranty DOES NOT COVER any damages arising from

(a) The negligence, gross negligence or willful misconduct of any third party; (b) Acts of God, including but not limited to, fire and lightning, hurricane, high winds; (c) Vandalism by any party; (d) Defects in the structure or a component of the structure (e.g., window, door or wall system) or selection of any components of the structure, or premature deterioration of the building materials, or nonstandard use of application of the Sentrigard SYN-P; (e) Foreign objects or agents, including incompatibility of materials; (f) UV exposure of the Sentrigard SYN-P in excess of that set forth in the Physical Properties Data Sheet; or (g) Improper installation of the Sentrigard SYN-P, improper building practices or design not in accordance with the applicable building code or industry standards, or any deviation from approved construction plans or project specifications. Sentrigard SYN-P must be installed in accordance with the Installation Guidelines that are in effect at the time of the installation of the Sentrigard SYN-P. How long Coverage Lasts

This Warranty runs for ten (10) years from the date on which the Sentrigard SYN-P was originally installed as a standard part of the building envelope. If the Sentrigard SYN-P is repaired or replaced, the Warranty will continue from the original date of installation and not from the date of repair or replacement.

Who can enforce this Warranty

Any owner who can provide proof of installation of Sentrigard SYN-P, after November 1, 2011 on a construction covered by and meeting the terms of this Warranty can enforce this Warranty. This Warranty is transferable to subsequent owners within the Warranty's 10-year coverage period. Notwithstanding the foregoing language, Sentrigard shall have no obligation under this Warranty unless and until Sentrigard, the authorized applicator, and the material suppliers have all been paid in full for all materials, supplies, services, and other costs which are included in, or incidental to, Sentrigard SYN-P,

What Sentrigard Will Do and What You Must Do

Sentrigard will pay for the cost of the materials and labor required to correct a problem caused solely by the failure of the Sentrigard SYN-P to meet the air and water penetration resistance properties in the applicable Physical Properties Data Sheet and the terms of this Warranty. You will be responsible for any other costs associated with or arising out of the repair or replacement or any other correction. You must reasonably cooperate with SENTRIGARD or its representatives in their efforts to perform their obligations under this Warranty.



How you can get Warranty Service

To obtain service under this Warranty, you must promptly contact SENTRIGARD at www.sentrigard.com or call 1-877-495-7663 regarding any potential claim, but no later than sixty (60) days after you discover any potential claim, and provide SENTRIGARD with proof of purchase and installation of Sentrigard SYN-P. You must provide SENTRIGARD with a reasonable opportunity to inspect the building within sixty (60) days after SENTRIGARD receives notice of your potential claim.

Exclusion of Damages

SENTRIGARD SYN - P'S LIABILITY UNDER THIS WARRANTY IS LIMITED TO THE COST OF THE MATERIALS AND LABOR REQUIRED TO CORRECT PROBLEMS CAUSED SOLELY BY THE FAILURE OF SENTRIGARD SYN-P TO MEET THE APPLICABLE PHYSICAL PROPERTIES DATA SHEET. SENTRIGARD SHALL NOT BE LIABLE EITHER IN TORT OR IN CONTRACT FOR ANY DIRECT, INCIDENTAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES, OR LOST PROFITS, LOST REVENUE, OR LOSS OF USE, OR ANY BREACH OF ANY EXPRESS OR IMPLIED WARRANTY.

Limitation of Implied Warranties

ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IS LIMITED IN DURATION TO THE LENGTH OF THIS WARRANTY.
